Previous actions

All updated key documentation was provided to Troy Planning although some were provided quite a few weeks after the end of April deadline due to people being away on holiday.

Design Code

TH updated that we have been approached by Amanda Reynolds, Director of AR Urbanism, 63 Rivington Street, London, EC2A. They have been appointed by Locality to provide our neighbourhood forum with design code support for our neighbourhood plan.

They have been advised by Locality that we have already drafted a character area assessment which we need to provide to them as a useful start in terms of understanding our area and priorities within it.

They have suggested meeting with us on 23rd September at 12 noon as they need to receive and examine the work already completed by Troy Planning. The assigned planner will be Alec Scragg and he will make contact with CB to organise his travel. TH/CB would be able to collect Alec from Atherton train station at 12.00 which is the nearest train station and then do a tour around the area in the car around for a couple of hours so that he can collect photographs and make notes before heading to examine the paperwork.

The funding is paid by Locality directly to AR Urbanism once they have completed the work on our project. Following the meeting, a provisional programme will be sketched out that shows work stages and reflective of the initial deadline for the work to be completed given by Locality as end of November.

The visit's proposed agenda would be to :

Drive around Neighbourhood Area with discussion on current design issues

- Discussion of current state of the Neighbourhood Plan
- Discussion of Troy Planning's baseline analysis and local green space assessment
- The Neighbourhood Plan's ambitions for the Design Code
- Initial thoughts regarding potential for the Design Code
